## Director's Order under Section 157 of the *Consumer Protection Act*

TO

Mildred (Lauria Leen) XAYSANASY of [REDACTED] Edmonton, Alberta

### Issues

The Alberta Motor Vehicle Industry Council (AMVIC) has identified the following issue during the course of an investigation:

On April 19, 2018 Mildred (Lauria Leen) XAYSANASY applied and obtained a salesperson registration under the name of Lauria Leen XAYSANASY, in an attempt to mislead AMVIC by hiding her true identity.

This contravenes section 127(b)(iii) of the *Consumer Protection Act* (CPA). The contravention is as follows:

### **Refusal, Suspension, Cancellation, Terms**

**127(b)(iii) furnishes false information or misrepresents any fact or circumstances to an inspector or to the Director.**

### DIRECTOR'S ORDER

The Respondent, Mildred (Lauria Leen) XAYSANASY must **immediately**:

1. Cease working as an automotive salesperson
2. Be available when requested by the Director for a licensing hearing
3. Review AMVIC website at <http://www.amvic.org/industry-3/licensing/apply-licence-registrationrenewals/> for licensing requirements

### NON COMPLIANCE WITH ORDER

**ANY PERSON WHO FAILS TO COMPLY WITH AN ORDER OF THE DIRECTOR UNDER SECTION 157 OF THE CONSUMER PROTECTION ACT CONTRAVENES THIS ACT AND IS GUILTY OF AN OFFENCE AND MAY BE PROSECUTED PURSUANT TO SECTION 163 OF THE CONSUMER PROTECTION ACT.**

**REFUSAL, SUSPENSION, CANCELLATION, TERMS**

**SECTION 127 (B)(i) CONSUMER PROTECTION ACT STATES:**

**THE DIRECTOR MAY REFUSE TO ISSUE OR RENEW A LICENCE, MAY CANCEL OR SUSPEND A LICENCE AND MAY IMPOSE TERMS AND CONDITIONS ON A LICENCE FOR THE FOLLOWING REASONS**

- (i) FAILS TO COMPLY WITH AN ORDER OF THE DIRECTOR UNDER SECTION 129 OR 157, UNLESS, IN THE CASE OF AN ORDER UNDER SECTION 129 OR 157, THE ORDER HAS BEEN STAYED**
