Director's Order under Section 157 of the *Consumer Protection Act*

TO

Kalied RIFAHIE

Issues:

On April 20, 2018 a complaint was received by the Alberta Motor Vehicle Industry Council (AMVIC) that Kalied RIFAHIE of [REDACTED] is engaged in unlicensed motor vehicle repairs and sales at a residential address. AMVIC records show Kalied RIFAHIE has never been issued any class of license to repair nor operate a motor vehicle business by the regulator AMVIC.

City of Calgary records show Kalied RIFAHIE does not hold an active business licence issued by the City of Calgary to operate a motor vehicle business.

The AMVIC investigation has shown Kalied RIFAHIE is engaging in the repair and sale of motor vehicles contrary to s. 104(1) of the *Consumer Protection Act* of Alberta.

Order

The Respondent (s), Kalied RIFAHIE, must immediately:

1. Cease the repair and sale of all motor vehicles that are not personally registered to him for his daily use while unlicensed to do so under s. 104 (1) of the *Consumer Protection Act* of Alberta.

NON COMPLIANCE WITH ORDER

ANY PERSON WHO FAILS TO COMPLY WITH AN ORDER OF THE DIRECTOR UNDER SECTION 157 OF THE *CONSUMER PROTECTION ACT* CONTRAVENES THIS ACT AND IS GUILTY OF AN OFFENCE AND MAY BE PROSECUTED PURSUANT TO SECTION 163 OF THE *CONSUMER PROTECTION ACT*.

REFUSAL, SUSPENSION, CANCELLATION, TERMS

SECTION 127 (b) (i) *CONSUMER PROTECTION ACT* STATES:

THE DIRECTOR MAY REFUSE TO ISSUE OR RENEW A LICENCE, MAY CANCEL OR SUSPEND A LICENCE AND MAY IMPOSE TERMS AND CONDITIONS ON A LICENCE FOR THE FOLLOWING REASONS:

- (i) FAILS TO COMPLY WITH AN ORDER OF THE DIRECTOR UNDER SECTION 129 OR 157, UNLESS, IN THE CASE OF AN ORDER UNDER SECTION 129 OR 157, THE ORDER HAS BEEN STAYED.
