ISSUE(S)

The Alberta Motor Vehicle Industry Council (AMVIC) has identified the following issue during the course of an investigation.

Hussin NADHIM and 2316554 Alberta Ltd. of Calgary, Alberta is engaged in unlicensed, designated automotive business activity.

Hussin NADHIM and 2316554 Alberta Ltd. is engaged in unlicensed motor vehicle sales activity requiring an AMVIC issued licence, in contravention of the following:

Consumer Protection Act

Section 104(1)

DIRECTOR'S ORDER

That Hussin NADHIM and 2316554 Alberta Ltd. and any other employee, representative or agent, <u>immediately cease engaging in a designated automotive business</u> within the province of Alberta until properly licensed as per Section 104(1) of the *Consumer Protection Act* (CPA).

Hussin NADHIM and 2316554 Alberta Ltd. must immediately:

- 1. Cease all unlicensed, designated automotive business activity while unlicensed to do so under Section 104(1) of the *Consumer Protection Act*.
- 2. Remove all ads on mass media that offer unlicensed, designated automotive business activity until properly licensed with the regulator AMVIC, to engage in this activity.

NON COMPLIANCE WITH ORDER
