This Director's Order was issued under Section 157(1) of the Consumer Protection Act (CPA) in response to, in the opinion of the Director, contraventions of the CPA. As mandated by Section 157(3) a person or publisher who is subject to an order under this section may appeal under Section 179.

DIRECTOR'S ORDER UNDER SECTION 157 OF THE CONSUMER PROTECTION ACT

ISSUE(S)

The Alberta Motor Vehicle Industry Council (AMVIC) has identified the following issue during the course of an investigation.

Hughcon Earl Henry of Calgary, Alberta, is engaged in unlicensed designated automotive business activity, specifically the recycling and dismantling of motor vehicles and the sale of their parts, in contravention of the following:

Consumer Protection Act

Section 104(1)

DIRECTOR'S ORDER

That Hughcon Earl Henry and any other employee, representative or agent, <u>immediately cease engaging</u> <u>in a designated automotive business</u> within the province of Alberta until properly licensed as per Section 104(1) of the *Consumer Protection Act* (CPA).

Hughcon Earl Henry must immediately:

- 1. Cease all unlicensed, designated automotive business activity while unlicensed to do so under Section 104(1) of the Consumer Protection Act.
- Remove all ads on mass media that offer unlicensed, designated automotive business activity until properly licensed with the regulator AMVIC, to engage in this activity.

NON COMPLIANCE WITH ORDER

ANY PERSON WHO FAILS TO COMPLY WITH AN ORDER OF THE DIRECTOR UNDER SECTION 157 OF THE CONSUMER PROTECTION ACT CONTRAVENES THIS ACT AND IS GUILTY OF AN OFFENCE AND MAY BE PROSECUTED PURSUANT TO SECTION 163 OF THE CONSUMER PROTECTION ACT.

REFUSAL, SUSPENSION, CANCELLATION, TERMS

SECTION 127(b)(i) CONSUMER PROTECTION ACT STATES:

THE DIRECTOR MAY REFUSE TO ISSUE OR RENEW A LICENCE, MAY CANCEL OR SUSPEND A LICENCE AND MAY IMPOSE TERMS AND CONDITIONS ON A LICENCE FOR THE FOLLOWING REASONS:

(i) FAILS TO COMPLY WITH AN ORDER OF THE DIRECTOR UNDER SECTION 129 OR 157, UNLESS, IN THE CASE OF AN ORDER UNDER SECTION 129 OR 157, THE ORDER HAS BEEN STAYED.
