This Director's Order was issued under Section 157(1) of the *Consumer Protection Act* (CPA) in response to, in the opinion of the Director, contraventions of the act. As mandated by Section 157(3) a person or publisher who is subject to an order under this section may appeal under Section 179.

ISSUE(S)

The Alberta Motor Vehicle Industry Council (AMVIC) has identified the following issue during the course of an investigation.

Ahmad ABDUL RAHMAN of Calgary, Alberta, is engaged in the sale of motor vehicles to the public, a designated automotive business activity in Alberta, for which he does not hold the required licence class, in contravention of the following:

Consumer Protection Act

Section 104(1)

Ahmad ABDUL RAHMAN and Souad ABDUL RAHMAN of Calgary, Alberta, have failed to create and maintain business records associated to the AMVIC licensed wholesale business, City Best Trucking Ltd. o/a Ahmad's Auto Sales, in contravention of the following:

Consumer Protection Act

Section 132(1) and Section 132(2)

DIRECTOR'S ORDER

That Ahmad ABDUL RAHMAN and Souad ABDUL RAHMAN, City Best Trucking Ltd. o/a Ahmad's Auto Sales and any other employee, representative or agent, <u>immediately cease engaging in a designated</u>



<u>automotive business</u> within the province of Alberta until properly licensed as per Section 104(1) of the Consumer Protection Act (CPA).

Ahmad ABDUL RAHMAN, Souad ABDUL RAHMAN and City Best Trucking Ltd. o/a Ahmad's Auto Sales must immediately:

- 1. Create and maintain complete and accurate financial records of its operations in Alberta for at least three years after the records are made and must make these records available for inspection by an inspector, at a place in Alberta and at a time specified by the inspector.
- 2. Cease all unlicensed, designated automotive business activity while unlicensed to do so under Section 104(1) of the *Consumer Protection Act*.
- 3. Remove all ads on mass media that offer unlicensed, designated automotive business activity until properly licensed with the regulator AMVIC, to engage in this activity.
- 4. Review AMVIC website at: www.amvic.org/business/business-licence/apply-licence-registrationrenewals/ for licensing requirements.
- 5. Create and maintain complete and accurate business records and make these records available to an inspector in Alberta at a time and place specified by the inspector.

NON COMPLIANCE WITH ORDER

ANY PERSON WHO FAILS TO COMPLY WITH AN ORDER OF THE DIRECTOR UNDER SECTION 157 OF THE CONSUMER PROTECTION ACT CONTRAVENES THIS ACT AND IS GUILTY OF AN OFFENCE AND MAY BE PROSECUTED PURSUANT TO SECTION 163 OF THE CONSUMER PROTECTION ACT.

REFUSAL, SUSPENSION, CANCELLATION, TERMS

SECTION 127(b)(i) CONSUMER PROTECTION ACT STATES:

THE DIRECTOR MAY REFUSE TO ISSUE OR RENEW A LICENCE, MAY CANCEL OR SUSPEND A LICENCE AND MAY IMPOSE TERMS AND CONDITIONS ON A LICENCE FOR THE FOLLOWING REASONS:

(i) FAILS TO COMPLY WITH AN ORDER OF THE DIRECTOR UNDER SECTION 129 OR 157, UNLESS, IN THE CASE OF AN ORDER UNDER SECTION 129 OR 157, THE ORDER HAS BEEN STAYED.
