DIRECTOR'S ORDER UNDER SECTION 157 OF THE *CONSUMER PROTECTION ACT*

This Director's Order was issued under Section 157(1) of the *Consumer Protection Act* (CPA) in response to, in the opinion of the Director, contraventions of the CPA. As mandated by Section 157(3) a person or publisher who is subject to an order under this section may appeal under Section 179.

Pursuant to Section 179, to appeal the order, the person must serve the Minister of Service Alberta with a notice of appeal within **thirty (30) days** after receiving the order. Please include your name, your address for service, details of the order being appealed and your reasons for appealing.

ISSUE(S)

The Alberta Motor Vehicle Industry Council (AMVIC) has identified the following issues during the course of an investigation.

The respondent has failed to provide business records available for inspection by an inspector at a place in Alberta and at a time specified by the inspector in contravention of the following:

Consumer Protection Act (CPA) Section 132(2) – fail to produce records

The respondent is advertising consignment sales and has failed to remove this advertising. The respondent is not authorized to carry on any class of activity that is not specified on the licence in contravention of the following:

Consumer Protection Act (CPA) Section 104(1) – unlicensed business

Automotive Business Regulation (ABR) Section 3(7) – unauthorized business activity

DIRECTOR'S ORDER

That 2286631 ALBERTA LTD. doing business as AUTOZONEYYC and its director Muhammad Nasim MEHRI must provide copies of all business records of 2286631 ALBERTA LTD. doing business as AUTOZONEYYC pertaining to AMVIC file 22-05-027 regarding the transaction involving the 2017 Ford Fusion to the AMVIC south office in Calgary, Alberta no later than Sept. 2, 2022.

That 2286631 ALBERTA LTD. doing business as AUTOZONEYYC and its director Muhammad Nasim MEHRI must immediately remove all consignment sales advertising until properly licensed with the regulator.

2286631 ALBERTA LTD. doing business as AUTOZONEYYC and its director Muhammad Nasim MEHRI must:

1. Comply with providing business records of 2286631 ALBERTA LTD. doing business as AUTOZONEYYC no later than Sept. 2, 2022.
2. Immediately remove all consignment sales advertising on mass media until properly licensed with the regulator AMVIC to engage in this activity.
3. Cease all unlicensed, designated automotive business activity while unlicensed to do so under Section 104(1) of the *Consumer Protection Act*.
4. Review AMVIC website at: www.amvic.org/business/business-licence/apply-licence-registrationrenewals/ for licensing requirements.

NON COMPLIANCE WITH ORDER

ANY PERSON WHO FAILS TO COMPLY WITH AN ORDER OF THE DIRECTOR UNDER SECTION 157 OF THE *CONSUMER PROTECTION ACT* CONTRAVENES THIS ACT AND IS GUILTY OF AN OFFENCE AND MAY BE PROSECUTED PURSUANT TO SECTION 163 OF THE *CONSUMER PROTECTION ACT*.

REFUSAL, SUSPENSION, CANCELLATION, TERMS

SECTION 127(b)(i) *CONSUMER PROTECTION ACT* STATES:

THE DIRECTOR MAY REFUSE TO ISSUE OR RENEW A LICENCE, MAY CANCEL OR SUSPEND A LICENCE AND MAY IMPOSE TERMS AND CONDITIONS ON A LICENCE FOR THE FOLLOWING REASONS:

- (i) FAILS TO COMPLY WITH AN ORDER OF THE DIRECTOR UNDER SECTION 129 OR 157, UNLESS, IN THE CASE OF AN ORDER UNDER SECTION 129 OR 157, THE ORDER HAS BEEN STAYED.
