DIRECTOR'S ORDER UNDER SECTION 157 OF THE CONSUMER PROTECTION ACT

This Director's Order was issued under Section 157(1) of the *Consumer Protection Act* ("CPA") in response to, in the opinion of the Director, contraventions of the CPA. As mandated by Section 157(3) a person or publisher who is subject to an order under this section may appeal under Section 179.

Pursuant to Section 179, to appeal the order, the person must serve the Minister of Service Alberta and Red Tape Reduction with a notice of appeal within **thirty (30) days** after receiving the order. Please include your name, your address for service, details of the order being appealed and your reasons for appealing.

ISSUE

On August 21, 2023, the Alberta Motor Vehicle Industry Council ("AMVIC") was to perform an inspection on 2017480 Alberta Inc. o/a Karachi Motors (the "Supplier"). It was found the Supplier had contravened legislation as set out in the CPA and the Automotive Business Regulation.

The Inspector arrived at the Supplier's business office located at Bay D, 254 Gregoire Drive, Fort McMurray, Alberta. The business office was closed and the doors were locked. Signage on the business door stated "For Lease". The building had no signage indicating the business was in operation. The inspection was unable to occur. An inspection findings letter was emailed to Malik Orangzeb on September 6, 2023 stating the Supplier had until September 15, 2023 to provide AMVIC with an updated municipal licence. The Inspector called Malik Orangzeb on September 18, 2023 and Malik Orangzeb informed the Inspector he was unable to find a new physical location.

All licensees must have a physical location to sell vehicles.

Consumer Protection Act Notification of changes

Section 134(1) Every licensee must notify the Director in writing within 15 days of (a) a change in the address of the licensee's business office,

Automotive Business Regulation Complying with laws

Section 4(1) The Director may refuse to issue or to renew a licence to an applicant if

(a) the applicant is unable to satisfy the Director that the applicant is complying with laws, including municipal bylaws, that apply to the automotive business to be operated under the licence,



Automotive Business Regulation General Codes of Conduct

Section 12(o) Comply with any legislation that may apply to the selling, leasing, consigning, repairing, installing, recycling or dismantling of vehicles

DIRECTOR'S ORDER

That 2017480 Alberta Inc. o/a Karachi Motors, must immediately:

1. Cease selling vehicles from any location until AMVIC is provided with an updated municipal licence.

NON COMPLIANCE WITH ORDER

ANY PERSON WHO FAILS TO COMPLY WITH AN ORDER OF THE DIRECTOR UNDER SECTION 157 OF THE CONSUMER PROTECTION ACT CONTRAVENES THIS ACT AND IS GUILTY OF AN OFFENCE AND MAY BE PROSECUTED PURSUANT TO SECTION 163 OF THE CONSUMER PROTECTION ACT.
