ISSUE(S)

The Alberta Motor Vehicle Industry Council (AMVIC) has identified the following issues during the course of an investigation.

2039795 Alberta LTD. o/a Coulee Collision, located at 2702 2 Avenue N in Lethbridge, Alberta, is operating without an AMVIC licence.

Consumer Protection Act (CPA)

Licence required: designated business

Section 104(1) – "No person may engage in a designated business unless the person holds a licence under this Act that authorizes the person to engage in that business."

DIRECTOR'S ORDER

That 2039795 Alberta LTD o/a Coulee Collision and any other employee, representative or agent, immediately cease engaging in unlicensed automotive business activity within the province of Alberta until properly licensed as per Section 104(1) of the *Consumer Protection Act*.

Jacobus SMIENK, 203975 Alberta LTD. o/a Coulee Collision must immediately:



- 1. Cease engaging in unlicensed automotive business activity while unlicensed to do so under Section 104(1) of the *Consumer Protection Act*.
- 2. Remove any and all advertisements on mass media communication sites and platforms that solicit the unlicensed activity until it has been issued a licence to lawfully operate by the regulator AMVIC.

NON COMPLIANCE WITH ORDER

(i) FAILS TO COMPLY WITH AN ORDER OF THE DIRECTOR UNDER SECTION 129 OR 157, UNLESS, IN THE CASE OF AN ORDER UNDER SECTION 129 OR 157, THE ORDER HAS BEEN STAYED.
